Change in income criteria to avail DJ-GIFT Scheme

Directorate of Technical Education, Govt. of Goa, vide their Notification No. DTE/DJ-GIFT/EDUCATION SCHEME/2021-22/582 dated 13th August 2024, has notified a change in income criteria to avail DJ-GIFT Scheme.

CHANGE IN INCOME CRITERIA

Students admitted in 2024-2025

(newly admitted First Year and Second Year Lateral Entry students)

For the students admitted in 2024-2025, the DJ-GIFT Scheme shall be applicable **provided both conditions i.e. (a) AND any one of (b) are satisfied:**

(a) Total annual family income from all sources should not exceed Rs. 12 lakhs per annum for financial year 2023-2024

AND

(b) Student is admitted under General / SC / ST / OBC / Goan Native / PWD / EWS / Management Quota (fulfilling requirements of General Category students)

OR

(b) Student is admitted under ESM / CSP / NRI-GO / LA / OGA category AND either of the parents / grandparents of the student was born in Goa (Document to be submitted: birth certificate of parent / grandparent)

OR

(b) Student is admitted under ESM category AND he / she has 10 years residence in Goa preceding his / her admission to First Year Engineering (Document to be submitted: School and higher secondary bona-fide certificate(s) provided the period of Residence is clearly established from the same OR Residence Certificate which was issued at the time of admission)

OR

(b) Student is admitted to Direct Second Year - having passed Diploma from Board of Technical Education, Goa OR either of the parents / grandparents of the student was born in Goa OR the student has passed Std. X / Std. XII exam from an institute in Goa and has 10 years residence in Goa, preceding his / her diploma admission outside Goa.

Students admitted in 2023-2024

(current Second Year students and current Third Year students who had been admitted through lateral entry last year)

- The change in income criteria is also applicable to students admitted in 2023-2024 with effect from the year 2024-2025.
- Other eligibility criteria remain unchanged - *refer conditions (a) and (b) above*
- Base fees remain the same as notified last year (*see below structure*)

BASE FEES

PROCEDURE TO APPLY


Students who have now become eligible under DJ-GIFT Scheme after this notification, may apply as follows:

- 1) **Submit income certificate of financial year 2023-2024** - Income Certificate should be issued by the Chief Officer of Municipality in case of Municipal areas or Panchayat in case of village areas, and should contain the wording “total annual family income from all sources”

Mode of submission of income certificate

- Students admitted in 2024-2025: Submit original and one xerox copy to Admin Section and one xerox copy to Accounts Section at PCCE on any day between 2nd to 5th September 2024
- Students admitted in 2023-2024: Upload on “DJ-GIFT Renewal - Income Certificate upload form” link bit.ly/pcceverna_incomecertuploadform

- 2) **Excess semester fees paid** - The excess amount already paid as current semester fees will be adjusted against fees due for next semester.
