Declaration of results	Immediately after record of votes on 9 <sup>th</sup> October 2024

#### **ELECTIONS WILL BE HELD FOR FIVE UCR POSTS:**

- 1. UCR for First Year B.E.
- 2. UCR for Second Year B.E.
- 3. UCR for Third Year B.E.
- 4. UCR for Final Year B.E.
- 5. UCR for First Year M.E.

In case of a tie, the winner will be decided by drawing lots.

Students interested in contesting are required to file their nominations in the prescribed format (4 page form attached below this notice) and submit the same to the Asst. Registrar.

### **Rules and regulations**

Students who wish to stand for elections for UCR must meet the following requirements:

- a) Age should not be more than 26 years.
- b) The student should have no backlogs of any courses of earlier examinations (internal or external).

- c) The student should not have been admitted to the class from which he/she is contesting by getting the benefit of ATKT.
- d) The student should not be a repeater in the class from which he/she is contesting the elections.
- e) The student should not have a past criminal record or have been involved in cases of indiscipline or suspended from the College in the previous year.
- f) The students shall cease to be the UCR if they fail to appear or pass at the next University examination.
