Elections for the posts of **Students Council and Ladies Representative (LR)** for the academic year 2024-2025 will be held as per the following schedule:

<b>Last date to receive nominations</b>	<b>Tuesday, 8<sup>th</sup> October 2024 upto 1.00 p.m.</b>
Scrutiny of nominations	Thursday, 10 <sup>th</sup> October 2024 from 11.30 a.m. to 1.00 p.m.
Withdrawal of candidature	Friday, 11 <sup>th</sup> October 2024 upto 1.00 p.m.
Date of election / record of votes	Tuesday, 15 <sup>th</sup> October 2024 from 12.00 noon to 1.00 p.m.
Declaration of results	Immediately after record of votes on 15 <sup>th</sup> October 2024

Nominations have to be filed as a 4-member panel consisting of **GENERAL SECRETARY, SPORTS SECRETARY, CULTURAL SECRETARY AND MAGAZINE SECRETARY**, with one candidate from each of the 4 departments, **COMP, ECOMP, MECH and IT**. Elections will take place among panels and not among individual candidates.

Nominations for the post of **LADIES REPRESENTATIVE** have to be filed separately. **Only girl students will vote for the LR.**

In case of a tie, the winning panel / LR candidate will be decided by drawing lots.

**Students interested in contesting are required to file their nominations in the prescribed formats (attached below this notice) and submit the same to the Asst. Registrar.**

## Rules and regulations

Students who wish to stand for elections for Students Council / LR must meet the following requirements:

- a) Age should not be more than 26 years.
- b) The student should have no backlogs of any courses of earlier examinations (internal or external).
- c) The student should not have been admitted to the class from which he/she is contesting by getting the benefit of ATKT.
- d) The student should not be a repeater in the class from which he/she is contesting the elections.
- e) The student should not have a past criminal record or have been involved in cases of indiscipline or suspended from the College in the previous year.
- f) The students shall cease to be the Students Council member / LR if they fail to appear or pass at the next University examination.
- g) No student shall contest elections to more than one position of the Students Council.
