1. The Examinations for Theory shall be conducted from **02-01-2026**. The detail Time – Table shall follow separately.
2. The examination fees shall be applicable as per the fee structure for the academic year 2025-26 notified vide Notification No. **GU/EXAM FEE/20/2025/77** dated **10-06-2025**.
3. The Principal of the College should ensure that the examination forms submitted by the candidates are complete in all respects and duly checked before forwarding to the University. Similarly, the eligibility of the respective candidates as per the Rules/Ordinance for appearing at the concerned examinations/semesters shall also be **verified and checked by the Principal of the College** before sending the applications to the University.
4. **Exam fees** to be paid by the students to the college account. College to send consolidated payment to the University along with the forms.
5. The Principal of the college shall forward NSS marks to NSS Coordinator and Sports marks to Asst. Director of Sports, along with duly certified list of the students by **22/12/2025**. NCC's Cultural/Sports marks duly signed by the Principal to be sent to Examination section by **29/12/2025**
6. Incomplete forms, i.e., forms without Permanent Registration Numbers, etc. and which are not accompanied by the prescribed fee, and forms received after the date indicated in Column No.3 above, **will not be accepted by the University**.
7. Sessional marks **to be sent in Excel format (compulsory)** along with the hard copy signed by the Principal by **29-12-2025**.
8. A guide should sign the dissertation only after ensuring that the dissertation will not invoke charge of plagiarism when the soft copy (on a CD) of the final version and the required number of hard copies are submitted to the University.
9. Four copies of the dissertation and soft copy on CD (wherever applicable) may be submitted by **29-12-2025** after the end of the term. **Dissertation Approval Sheet in terms of the provisions of the Ordinance OC-11A.6 (ii) has to be enclosed.** The Dissertation should meet the requirements of Circular No.GU/Exam/55/2016/1633 dated 17-02-2016.
10. College should not accept any form after **07-11-2025** under any circumstances.
11. The last date of submission of examination forms by the College to the University is **10-11-2025**.
